The board is leading the admin hiring process and I'll keep you updated on progress. This week, I'm introducing our fifth community agreement to you: **We approach conflict directly, productively, and with compassion.** Conflict is a natural part of being human and it doesn't have to be a bad thing. As LISD staff members, that is our aspiration and what we wish to model for our students.

Listening Circle

There is some confusion about attendance for PACK. It is an attendance requirement for secondary students with the exception of full time parent partner students. I sincerely believe that PACK is an important part of the school day where students are connecting with each other in fun and meaningful ways, discussing digital citizenship, and learning productivity skills. I also understand that students are experiencing Zoom fatigue. A parent can unenroll a child from PACK by sending Ronda a message to that effect. Ronda will then take them off the PACK enrollment list and they will not be counted absent. I do hope that most students will remain enrolled and engaged in PACK. We are trying really hard to ensure that it is time well spent.

From Karen Hattman, our School Nurse

As we move forward during the COVID epidemic we must plan ahead for school to reopen. Part of this process is up to date immunization records. The state has issued requirements that all students must have the following immunizations to attend in-person school. Please see the list below and make sure your child has all the immunizations required.

DTAP......5 doses HEP. B.....3 doses MMR.....2 doses Polio......4 doses Varicella...2 doses

Please provide the School Nurse with signed documentation of these immunizations. The new immunization law removed the option for personal or philosophical exemption for MMR immunization. There have been no other change in:

- Other personal/philosophical exemptions
- Religious, religious membership or medical exemptions
- Titer testing in lieu of immunization

If you have provided the school with a signed exemption from a licenced health care provider or physician, it is still in effect unless rescinded by the provider.

Thank you for your efforts to meet the state requirements.
