Resolution to Withdraw the Capital Projects Levy from the November 2021 Ballot


RESOLUTION NO. 20/21-21

- WHEREAS, the Board of Directors of the Lopez Island School District #144 adopted on July 28, 2021 the Capital Projects Levy Resolution 20/21-20 Capital Projects Levy for the purpose of providing for the submission to the qualified electors of the district at a special election to be held therein on November 2, 2021, of a proposition to authorize the district to levy an additional tax to provide a total of \$98,000 for the District's Capital Projects Fund for the purpose of making capital improvements to educational facilities, including modernizing its educational facilities, such levies to be made for five years commencing in 2021 for collection in the calendar years from 2022 through 2026, inclusive;
- WHEREAS, the Capital Projects Levy Resolution 20/21-9 a resolution approved on April 28th, 2021 by the Board of Directors of Lopez Island School District No. 144, San Juan County, Washington, providing for the submission to the qualified electors of the district at a special election to be held therein on August 3, 2021, of a proposition to authorize the district to levy an additional tax to provide a total of \$139,000 for the District's Capital Projects Fund for the purpose of making capital improvements to educational facilities, including modernizing its educational facilities, such levies to be made for five years commencing in 2021 for collection in the calendar years from 2022 through 2026, inclusive;
- WHEREAS, the voters of San Juan County, WA approved on August 3rd, 2021 the Capital Projects Levy of Resolution 20/21-9 and;
- WHEREAS, the Capital Projects Levy approved on July 28th, 2021 by the Board of Directors of Lopez Island School District, San Juan, WA of Resolution 20/21-20 now serves as a duplicate;
- THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF LOPEZ ISLAND SCHOOL DISTRICT NO. 144, SAN JUAN COUNTY, WASHINGTON the board shall withdraw the Capital Projects Levy approved on July 29th, 2021, referenced by Resolution 20/21-20.
